

## **CAMPING VELINO REGULATION**

- Art.1 Upon arrival, the camper is requested to go to the Acceptance Office where an identification document will be delivered for each individual member of his family and fill in the public security form. The documents will remain in custody at the Directorate for legal registrations and therefore returned. The arrival will be given a sticker that must be displayed on the windshield of the car to facilitate checking at the entrance of the campsite.
- Art.2 For the reservation, a deposit of 30% of the price of the stay must be paid, to be paid no later than 15 days from the request of the chosen structure (Bungalow, Mini-apartment, Pitch), under penalty of loss of the right of reservation. The balance is payable on arrival after the acceptance formality. Delays in arrival and early departures must be promptly communicated to the Management, and in any case entail payment of the entire booked period.
- **Art.3** By family we mean the head of the family, the spouse and the children. The head of the family responds personally to members of his family and to his guests.
- Art.4 If during a possible check by the authorized personnel, a higher number of people than the declared one occurs, an increase of € 3.00 per person will be applied starting from the day of registration, and the removal from the campsite.
- Art.5 The Guest will be able to access and stay in the Camping on the condition that the owner or person of his family is present. The number of guests, in order to avoid crowds and confusions that could damage the peace of the campers and the regular functioning of the toilets, will be established from time to time by the Management according to the number of people already present in the Camping. Guests will not be able to stay overnight on the campsite unless explicitly authorized by the Management, in the absence of which they will have to leave it before 22:00 after having paid the daily fee.
- **Art.6** The access of dogs is at the discretion of the Management, if allowed, they must strictly be on a leash and accompanied for their needs outside the structure, in the adjacent lawn.
- **Art.7** In the direction are posted all the times that regulate life in the Village which campers must comply with.
- Art.8 The camping timetable for customers is as follows:

Acceptance: am 9:00 - 12:00 | pm 4:00 - 7:00, Payments: matt. 9:00 am - 12:00 | pm 4:00 - 7:00 (we advise you to settle the bill the day before departure). The entry and exit of the equipment is limited between am 8:00 and 12:00, and between pm 4:00 and 8:00. Outside of these hours, equipment arriving or departing will have to stop in the appropriate waiting parking area. From pm 11 to am 7 in the morning and from 2 pm to 4 pm it is imperative to respect the quiet. During these hours it is forbidden to assemble or disassemble equipment, to circulate in the Village, by car, motorbike and bicycle, to harass with radio, tape player, games and songs.

- **Art.9** The assignment of the sector and the parking area is the exclusive responsibility of the Management. It is forbidden for the camper to make changes or modifications. The car and equipment must be parked exclusively in the area specifically reserved for them. In the assigned pitch, no more than one tent or caravan can be installed.
- **Art.10** The camper is obliged to keep the space assigned to him clean and tidy and to leave the common services clean. All waste they must be thrown into the appropriate containers. Each household must have suitable containers for the collection of used water. Furthermore it is expressly forbidden:

- a) let the children go to the services alone;
- b) lay breccia, bricks and derivatives within and outside your area c) install additional fixed systems such as tables, benches, hammocks, wires on trees etc. The management reserves the right to remove these structures if they create an obstacle or limitation of any kind
- d) wash dishes if not in the appropriate sinks;
- e) washing and hanging laundry to be dried outside the areas specifically set up in the service area;
- f) discharge used water onto the ground;
- g) attaching pipes to the fountains to draw water;

## Art.11 - It is strictly prohibited;

- a) light open fires with wood;
- b) to introduce firearms, rifles and compressed air pistols into the Village;
- c) damage plants, dig holes, mark furrows;
- d) washing equipment, cars and motorcycles;
- e) to bring motorcycles and mopeds into the village; these must always be parked in the car park reserved for them;
- f) install additional sockets;
- Art.12 The use of charcoal grills is allowed as long as the smoke does not disturb the neighbors and the lawn and the underlying soil are not damaged.
- Art.13 Parents are directly responsible for their children. Children must be supervised by their parents and in this regard, the Management declines all responsibility.
- Art.14 Any damage caused to the camping equipment will be compensated by the owner camper, who is also liable for any damage caused by his family and guests.
- Art.15 It is forbidden to use the car or other motor vehicles to move around the interior of the Village. Any motor vehicle that leaves the parking lot to exit the Village will actually have to leave it. The maximum speed allowed when traveling by car is 5 Km / h. Access by car inside is allowed EXCLUSIVELY upon arrival of the camper in the Village, to park the caravan or set up the tent, or for departure. For no other reason, exceptions to this provision are allowed.
- Art.16 Caravans and other housing units must, in accordance with the law, be equipped with a fire extinguisher and "static risk" insurance coverage to be proven on request. They must also be equipped with an insurance policy to cover fire risk and appeal to neighbors.
- Art.17 The Management is not liable for accidents for its own cause and for the theft of any object, money or other left unattended, it is also not liable for damages resulting from the fall of trees or branches.
- **Art.18** Gentlemen who have a daily booking are required to pay the bill upon entry.
- **Art.19** Failure to comply with the provisions of these Regulations, issued in the interest of our guests, leads to offenders, in the event of recidivism or serious accidents, leaving the Village without demanding any refund.
- **Art.20** The Camper declares to be perfectly aware of the regulations of this Campsite, for having viewed and collected a copy at the time of entry, and undertakes to observe the above mentioned for himself, and for his group or family.

A "REGULATION" by its nature is always conditioned by individual freedom which it wants to harmonize with the collective one. Its "RULES" of a general nature place restrictions fully justified by its aim of creating better conditions for a richer and more human civil coexistence, in terms of education, respect and mutual esteem. We therefore trust entirely on the awareness and consent of our welcome guest to comply with these modest limitations that will allow him to have a more serene, peaceful and relaxing stay, and will avoid the unpleasant intervention of the management to restore the troubled order.
